



## Terms and Conditions: Licensing Pilot Program

1. Program Overview The International Crown Licensing Pilot Program (hereinafter "Pilot Program") is exclusively provided by the International Crown Licensing Regulatory Authority and subject to the following comprehensive terms and conditions:

### 2. Eligibility Criteria

#### 2.1 Participation Restriction

- a) Participants must currently have or has held until voluntarily cancelling/challenging fines unrelated to road and/or traffic infractions at the time of participation
- b) Valid or previously valid "government"-issued identification will be required for verification
- c) Participants that hold a suspended or cancelled license for roads and/or traffic infractions are strictly prohibited

#### 2.2 Geographic Limitations

- a) Pilot Program valid only on the land mass of Terra Australis
- b) Participants must be physically located within authorised geographic boundaries during pilot program
- c) Residents of international countries are ineligible

### 3. Reporting Requirements

#### 3.1 Structure

- a) Reporting is confidential from other participants. Information submitted by you in your report will only be shared among staff
- b) Reporting updates will be collated anonymously and be available as updates to general public

#### 3.2 Reporting Contributions

- a) Use concise details only, there are provisions to upload media if available
- b) Must include each section with an asterisk
- c) Failure to submit report two (2) consecutive weeks with result in cancelled participation and license
- d) Some exclusions may apply to subsection c), pending circumstances, upon approval by the International Crown Licensing Regulatory Authority

#### 4. Pilot Program Expiry

- a) Start Date: 15<sup>th</sup> November 2025
- b) End Date: on or around 15<sup>th</sup> May 2026
- c) Pilot Program subject to immediate termination or extension without prior notice

#### 5. Responsible Conduct

- a) Participants must conduct themselves responsibly
- b) Participants agree to the regulations as defined in the International Crown Licensing Regulatory Authority “Licensing Scheme” available on the website

#### 6. Dispute Resolution

##### 6.1 Internal Resolution Process

- a) Disputes must be submitted in writing within 7 days
- b) Comprehensive investigation conducted by compliance team
- c) Written resolution provided within 21 business days

##### 6.2 Arbitration Clause

- a) Unresolved disputes subject to binding arbitration
- b) Governed by International Crown Courts legal framework consistent with the International Crown Licensing Regulatory Authority “Licensing Scheme”

#### 7. Program Modifications

- a) The International Crown Licensing Regulatory Authority reserves unconditional right to modify, suspend, or terminate this Pilot Program
- b) Changes communicated via official communication channels, as recorded on the application forms submitted to the International Crown Licensing Regulatory Authority
- c) Continued participation implies acceptance of modified terms

#### 8. Legal Compliance

- a) Program adheres to applicable regulatory standards
- b) Full compliance with licensing requirements
- c) Subject to ongoing regulatory review

#### 9. Privacy and Data Protection

- a) Personal information handled according to established data protection protocols
- b) Participant consent required for data processing

#### 10. Limitation of Liability

- a) Participants acknowledge the International Crown Licensing Regulatory Authority is not legally or lawfully liable for any and all participant conduct and/or interaction
- b) No compensation available
